The contract for the Fair Grounds has been accepted with the total fee of \$700, \$500 for the Grounds & \$200 for the Hall of Champions. There will not be an electric fee for the vendors.

The insurance should again be \$250 with the bill being received in March.

The new Parkway contact person is Cindy Shepherd. Sleeping room & ice cream social prices should be confirmed very soon.

Confirmation of registration & meeting room is also needed.

The color guards have been notified & will be at the Fair Grounds on Sunday. We have never given them a donation but we have just been informed that organizations usually do this to help cover their travel & Living History uniform expenses. Registration form corrections & additions have been made. Fee will be \$30 & will include 2 raffle tickets. 2<sup>nd</sup> car will remain at \$10.00.

Volunteers Tammi Raver & Summer Anderson will be assigned jobs as the need arises.

In Phil's absence Jerry reported that Phil has worked with Atlas for our printing needs.

Peden's has finished the logo & t-shirts will be ordered from them using the maroon colored, heavier textured, \$9, Gilban brand. We will sell them for \$15.00 & order fewer than we did last year. The trophies & dash plaques will be ordered from Awards Services Inc. from WA. They will be a metal plate on a wood plaque & the cost is very reasonable. The Veteran's Choice award will be done again this year.

Stan has finalized the plan for channel 13 plus is planning on working with Bob Price for radio & talk with Brian Scott about his radio program. They are planning a live remote from Fremont Motors during their show.

Fremont Motors is doing a Mo-Par Show similar to what Greiner's does for the Mustang

Show. Fremont is donating \$1000 to us which they have designated for the Cruise for Cash & raffles. There will be 3 classes of awards; 1960 to older, 60-80, 80 & newer with 2 awards in each class.

The Fair Grounds parking lot will have to be marked early Sunday morning with candlesticks which have been obtained from the City & stantions from Master Gardeners; all these supplies will require a pick up to haul them. A chairman for this committee is still in the works. Doug & Dennis offered to help.

The Cruise for Cash is being chaired by Dennis Day. The last card will be drawn at the ice cream social at the Parkway. Dennis is still working on the route. Will he need volunteers?

The Donut Cruise will begin at 8:30 from the Parkway. The route will go around the Bessemer Bend area & end at the National Historic Trail Center where Bruce & Tammi will do a program.

The raffles will all be from specifically donated funds. We will not buy a jukebox or pedal car unless we receive designated funds for those items. Jerry wants 5-7 large items donated & use 10-20 donated door prizes. Tickets for the large raffle items will be on sale on Sunday &

drawn at the awards ceremony with the door prizes being given away at the ice cream social. The Humane Society has not responded about the 50/50 raffle with them selling tickets & profit going to them.

Jerry B. is to contact Wyo Sport as to their involvement.

Bailey & Ray Parnell are working to get vendors arranged & hope to get a few new ones.

Valve Cover Races will again be chaired by Doug, John G. & Ralph & will be at same location at the Fair Grounds on Sunday.

The PPG paint truck will not be here this year, but Doug has already put in our request for 2017.

We do not receive funds from the city or convention bureau.

The meeting was adjourned at 8:00. The next meeting will be Feb. 3, 2016 at Goodwin's.
